NBA HOOPS FACTORY TOURNAMENT 2017

1. The Tournament

1.1 The Promoter is MoneyTime SAS. The tournament offers an opportunity for participants to attend the NBA HOOPS FACTORY TOURNAMENT 2017 at Hoops Factory Toulouse in July 2017 to win a trip to London to attend the NBA Global Games London 2018

1.2 No purchase necessary to enter.

1.3 These Terms & Conditions govern the conduct of the NBA HOOPS FACTORY TOURNAMENT 2017. Your participation means that you accept these Terms & Conditions. Please read these carefully prior to participate in the NBA HOOPS FACTORY TOURNAMENT 2017.

2. Eligibility

2.1 The promotion is open to European residents, except employees of the Promoter; the "NBA Entities," which includes the National Basketball Association (the "NBA"), the NBA Member Teams, NBA Media Ventures LLC, NBA Properties, Inc. and its affiliates; any of its subsidiaries, agents or any other business involved with the administration of this promotion, or members of the households of such employees. Entrants must be resident in the country from which they submit their entry. Entrants must be 14 years of age to enter the competition.

3. The Competition

3.1 Win a trip to London to attend the NBA Global Games London 2018.

3.2 To enter the promotion, the Participants must register online until June 1st 2017 via one of the following social channels: Twitter, Instagram, Facebook; or via Hoops Factory website or showing up at Hoops Factory.

3.3 Amongst all registered entries: a maximum of 60 teams of 4 players (3 + 1 substitute) will take part into the Qualification tournament at Hoops Factory Paris on June 10th; a maximum of 60 teams of 4 players (3 + 1 substitute) will take part into the Qualification

tournament at Hoops Factory Evry on June 17th; and a maximum of 60 teams of 4 players (3 + 1 substitute) will take part into the Qualification tournament at Hoops Factory Toulouse on June 24th.

1 x winning team from the Hoops Factory Qualification tournament in Paris, 1 x winning team from the Hoops Factory Qualification tournament in Evry and 28 winning teams from the Hoops Factory Qualification tournament in Toulouse will be eligible to participate in the NBA HOOPS FACTORY TOURNAMENT 2017.

3.4 The winning teams will be participating to the final tournament at Hoops Factory in Toulouse on July 1st. Each will be placed in a group and playing in the regular season. The best team of each group will be advancing the Round 16 with the two best second teams. Then, the winner of Round 16 will be qualified for quarter finals. The four winners of each games will be playing semi-finals. And the two winning teams will attend the final. The team who will win the final will be the NBA HOOPS FACTORY TOURNAMENT 2017 champion and will win the prize of a trip to London to attend the NBA Global Games London 2018.

3.5 The winners must have a valid passport / ID and must be compliant with any provisions of local Laws to enter their country of residence. Promoter shall not be liable if the winner and/or his/her guest is/are refused admittance to London.

4 The Prize

4.1 The prize for the winners of the NBA HOOPS FACTORY TOURNAMENT 2017 consists of 1 ticket to attend the NBA Global Games London 2018 in January 2018. The prize doesn't cover transportation and accommodation. If the winners are minors, they will be asking a parental authorization. Prize cannot be substituted for cash. The exact seat location will be made at the sole discretion of the promoter and NBA Entities.

4.2 If winners reject the prize they will forfeit the prize and no substitute or alternative will be available.

5 Miscellaneous.

5.1 In the event that, due to the acts or omissions of winner(s), the Promoter is unable to deliver the prize to the winner, that winner will forfeit the prize and no substitute or alternative will be available. No substitute winners will be selected.
